Fulfilling our mission to secure the stable supply of energy, we contribute to achieving global goals such as evaluation and measurement of atmospheric emissions and also periodic environmental assessments, indeed iHATHOR produces enough energy for cover all the energy needs of our factory by solar panels and nowadays we are reducing in 102 tonnes per year our emission of CO2 at the atmosphere equivalent to 237 petroleum barrels.
